Partner2Care Plus (P2C+) are a service within Sirona care and health CIC. Sirona provide our community health services in North Somerset, Bristol and South Gloucestershire.

Who we are

Partner2Care have offered support services to people with a Personal Health Budget since 2015.

Here at Partner2Care we are a small team comprising of Registered Nurse Assessors and Trainer, Payroll, Brokerage and Support Officers and Administrator, managed by our Business and Service Delivery Manager.

Our Nurse Assessors can visit you where you are living to help you to plan your care and support needs and develop a personalised care and support plan with you.

Our team of Payroll, Brokerage and Support Officers can also visit you where you are living to support you to set up the services you have chosen which could include the recruitment and employment of support staff, a payroll service for your employees and if you choose ongoing email and telephone support.

Our dedicated Trainer will develop and deliver a tailor made training programme for you and your support staff to equip you and your care team with the knowledge and skills you need so that you can be assured that your care is being delivered safely. We can also signpost to other health and social care providers or training providers.

Partner2Care Plus is an additional service developed by Partner2Care as a way to extend our services to all people who have care and support needs in their own home, whether funding is provided by the NHS, local authority or self-funded.

What we do

Partner2Care Plus provides a range of services for people who want assistance to manage their own care and support and to live a more independent, inclusive life. We are able to provide independent advice to support you or your loved ones if you need care at home and would like our help to arrange or manage this.

Our services are tailored to ensure you get the support you need to have choice, control and flexibility over your care.

Services we provide

We will work beside you to support you with recruiting, employing and paying your staff. We can visit you where you live to explain the help we can provide, this can be any or all of the below:

- Recruitment support from £35 + VAT per hire to include advertising, shortlisting, supported interviews & pre-employment checks
- Payroll support from £29 + VAT per month to include employer registration, liaising with HMRC on your behalf, calculating monthly payroll including payments and

statutory deductions and emailing payslips to your employees

- Full payroll support from £35 + VAT per month to include employer registration, liaising with HMRC on your behalf, calculating monthly payroll including payments and statutory deductions, emailing payslips, holding a bank account on your behalf, providing clear and simple reports for your records, dealing with all other payroll matters such as new starters, leavers, holiday pay, student loans, statutory sick pay, maternity leave, pensions and complete End of Year Returns for HMRC and email P60s to your employee(s)
- A Brokerage and Support service from £35 + VAT per month to include issuing contracts of employment, insurance brokerage, telephone/email support for staff management and signposting for employment law and advice
- Enhanced DBS checks for your employee(s) from £52 + VAT per employee
- A home visit to develop a personalised care and support plan with you from £100 + VAT
